## You won't be told what research studies your samples are used for.

We will not be able to tell you when or where researchers use your sample for a research study. Research projects that use donated samples and health and personal information (data) will be listed on the Health Precincts Biobank website:

Research findings will be published in scientific journals and presented at conferences. Findings will always be presented in such a way that you cannot be identified. Similarly, research is conducted in such a way that individual results cannot normally be returned to participants.

## Use of samples by drug or biotechnology companies.

Research involving your samples and data may lead to a product or treatment that is profitable for a company. You will not receive any financial benefit from discoveries arising from the use of your samples or data.

## Injury or complications as a result of participation in the Health Precincts Biobank.

There is no physical risk in collecting tissue for the Health Precincts Biobank beyond that of your hospital procedure. The collection of a blood sample may occasionally cause bruising.

Your samples could be held forever or until you choose to stop taking part.

## In summary, you are being asked to give your consent to:

- Donate samples to the UNSW Health Precincts Biobank for ethically approved health and medical research
- Have your sample linked to health and personal information (data) held by the NSW and Commonwealth governments
- Have your sample and health and personal information (data) stored securely and used for ethically approved health and medical research now and into the future

Thank you for taking the time to consider participating in the Health Precincts Biobank. Your donation will help medical research and the treatment of patients for years to come.



### The Health Precincts Biobank

A biobank is a collection of human samples such as tissue and blood, linked to patient information, which can be made available to researchers, now and into the future.

The Health Precincts Biobank (previously known as the Health Science Alliance (HSA) Biobank) provides a valuable resource to researchers so that they can increase our knowledge and understanding of disease, and enabling high quality medical research and education, leading to better health outcomes for all.

The Health Precincts Biobank is an initiative of UNSW Biospecimen Services and is a collaboration between UNSW Sydney and NSW Health Pathology.

Please read this Patient Information Brochure carefully. Feel free to ask questions and to discuss the Health Precincts Biobank with a relative, friend or your local health care worker.

If you agree to take part, you will be asked to sign a consent form once you understand what the Health Precincts Biobank is about.

## You are being asked to support health and medical research by donating a sample.

We are asking for you to consent to allow your samples (e.g. blood, tissue, urine), and personal and health information (including non-identifiable scans) to be collected by the Health Precincts Biobank for use in research and education. Your samples, or a portion of them, may be used immediately as part of an ongoing project, or they may be stored until they are used in future research.

### It is your choice to donate or not.

Participation is voluntary. You can talk to your healthcare team, family, or friends before you decide. If you decide to take part you are still free to change your mind at any time and without giving a reason. If you change your mind, some of your sample and health information may already have been used for research but we will destroy any samples we still have in storage. Your decision to say no or to withdraw consent will not affect your medical treatment nor your dealings with Medicare Australia.

### If you give your consent, the following may be collected:

- A small piece of tissue and/or fluid from the sample removed during your procedure
- A blood sample or a mouth swab/saliva sample

If you have had a prior operation or biopsy that relates to this procedure, we may also access this tissue. If you have another operation in the future within this Local Health District, signing the Health Precincts Biobank consent form will also allow us to collect a sample from that procedure.

## Your samples will be linked with your health and personal information (data).

The Health Precincts Biobank may also request access to relevant health information about you from the following sources:

Hospital, pathology, emergency department records

- State and national databases such as: Admitted Patients Data Collection; Registry of Births, Death and Marriages; and the NSW Cancer Registries
- Medicare Benefits Schedule records (your visits to health professionals) and the Pharmaceutical Benefits Scheme (your use of prescription medicines)

Your samples, and health and personal information (data), might be used for a range of different health or medical research studies, now and in the future.

Your samples and health data will be stored securely within Biospecimen Services at UNSW Sydney, until they are requested for research or education. All research and education projects must be approved by a Human Research Ethics Committee before access to your samples or data can be granted. Future research may examine causes of disease, prevention, diagnosis, treatment and genetics. Future education uses may involve teaching medical, science and nursing students.

Like a bank, samples and personal and health information are kept under secure and tightly controlled conditions. If a breach of privacy happens it will be dealt with in line with relevant privacy laws and guidelines.

## Your name and address are removed from your samples.

Your samples and other information will be assigned a unique code used by researchers. Your name and identifying details will be in a separate file that is not available to researchers. This maintains your confidentiality. All information is stored securely.
